ENGINEERING FIRM, DEVELOPER, ARCHITECT

- a. Agree to submit application and registration fee of \$25.00.
- b. Agree to submit one (1) set of 24" x 36" paper detail drawings and one (1) electronic copy in pdf format (including plan and profiles, proposed and existing topography and all buried utilities) and specifications of all proposed sanitary sewer and water line drawings on shall be submitted for review and approval to: Erie County Sanitary Engineer, c/o D.O.E.S., 554 River Road, Huron, Ohio, 44839. Upon approval of the detail drawings and specifications for construction, the Engineering Firm/ Developer/Architect will have one (1) year from approval date to complete the construction of the water and sanitary sewer lines or will have to resubmit for approval and at a minimum be subject to any new D.O.E.S. requirements.
- c. Agree to submit and have current BWC Certificate and Certificate of Liability Insurance on file at DOES at all times.
- d. Agree to follow all Erie County Sewer and Water Rules, Specifications and Construction Standards governing construction and installation of sanitary sewer service connections and water service connections which are ultimately connected to the County's public sanitary sewer system and water distribution system.
- e. Agree to hold harmless Erie County, for any bodily, personal or real property damage resulting from the actions of my employees, equipment, and sub-contractors.
- f. Erie County DOES may deny registration to anyone who has failed to follow Erie County rules, specifications and standards.

- e. Upon approval of the detail drawings and specifications for construction, you will have one (1) year from approval date to complete the construction of the water and sanitary sewer lines or will have to resubmit for approval and at a minimum be subject to any new D.O.E.S. requirements.
- f. Agree to follow all Erie County Sewer and Water Rules, Specifications and Construction Standards governing construction and installation of sanitary sewer service connections and water service connections which are ultimately connected to the County's public sanitary sewer system and water distribution system.
