President Shenigo called the meeting to order at 9:30 a.m. and opened with the Pledge of Allegiance.

# County Administrator re Various Issues.

<u>Sales Tax</u> - Preliminary sales tax collections for January sales totaled \$1.4 million, or 7 ½% more than last year. Year-to-date, sales tax collections total \$6.6 million, or 4% higher than last year.

<u>Proclamation</u> - there is a proclamation going before the Board today to acknowledge Child Abuse Prevention Month. Erie County Department of Job and Family Services has been active on social media to spread the word about child abuse and in commemoration of this, the Commissioners' and their staff wore blue at today's meeting to show support.

<u>Water Rate Increase Public Hearing</u> - Hank reminded the Board that next Wednesday will be the second public hearing regarding the City of Sandusky's water rate increase.

Mr. Old would like to ensure that the City is invited to this public hearing. Mr. Old stated it would benefit Erie County to understand how the City is in this position regarding their negative fund balance. Mr. Old stated the only people who are negatively impacted by this are the taxpayers. Mr. Solowiej stated he has submitted requests' for public records to the City to gain insight regarding this matter, and has not received records back as of yet.

Grant Funded Program - Mr. Old noted that several years ago, the county started allocating money from the Motor Vehicle License and Gas Tax Fund to a newly created fund to assist the townships in upgrading their roads. This program has invested \$3 million over three years in Township roads.

Mr. Old would also like to create an account for infrastructure grant projects that cities, townships and villages can utilize to assist with their infrastructure projects, similar to OPWC and CDBG grant funds. A committee will be created and \$500,000 will be the targeted funding amount for this year. The projects will be submitted to Erie County and onto the review committee to review and score the projects, with the Commissioners having the final decision on which projects would be awarded and the amount of the award. County Administrator Hank Solowiej is in support of this grant program to ensure that villages, townships, and cities have the chance to invest in their parks and recreation, roads, and/or safety services equipment. Mr. Shenigo added that many of these entities are smaller municipalities with much smaller budgets, therefore this grant fund program is a win-win situation.

Mr. Shoffner stated this grant fund program will be a game changer for the small communities and will have a positive effect on all the citizens in Erie County. This program will help these entities perform upgrades they otherwise would not be able to do.

Mr. Old stated that the application process will likely take place once per year, as the County's budget permits. It is the hope that the parameters of the program and scoring sheet will be finished by the end of this month.

Equipment Outlay and Request Form - Revised - Mr. Old inquired about the revised Equipment Outlay and Request Form that the Engineer's submitted for the Rear Cross Conveyor and shoulder conditioner (berm box). Hank stated that the power hydraulic was added, to increase the original request amount by \$10,000. The Commissioners will approve as long as the Engineer's Office eliminates the road grater, broom and flaggers.

#### Public Comment.

Rick Scheel, 4525 Galloway Road, Sandusky, stated he has been following the water rate issue in the newspaper and appreciated Mr. Solowiej's response to the City.

His comment today is regarding the traffic issue on Galloway Road. Mr. Scheel has spoken with Huron and Perkins Townships' law enforcement. The issue is commercial vehicles, such as cement mixers, are using Galloway as a short cut to get to Sports Force. There is a 20 ton limit on Galloway. He understands that these commercial trucks have to get a permit and then they can travel this road legally. He mentioned that Galloway Road is a neighborhood comprised of people of all ages and is concerned for their safety.

Mr. Shenigo stated he will speak to the Sheriff about this on-going issue, especially regarding the heavy trucks traveling that road.

Mr. Old noted that the Engineer's submitted their township road work for 2024. Mr. Old is pleased that \$1.7 million in resurfacing work is being done this year in the Townships. Mr. Old believes this has been dramatically helped the County has given to the Townships for their road improvements.

Mr. Old noted that the Engineer's Office is spending a total of \$317,000 on professional services for the design of a bridge on Mason Road. He recalled that the Engineer's Office wanted to purchase software to design a roundabout.

Mr. Old inquired whether it would be in the best interest of the taxpayers if the Engineer's Office could purchase software to help the Engineer's Office design a bridge instead of hiring an expensive company to do it for them. Mr. Old believes that the Engineer and his staff have the credentials in order to design a bridge.
