## WEDNESDAY, JULY 26, 2023

ALL PRESENT

President Shenigo called the meeting to order at 9:30 a.m. and opened with the Pledge of Allegiance.

On motion of Mr. Shoffner and second of Mr. Old, Bard awards bid for **Kelley Road Elevated Water Storage Tank Painting and Rehab** to **FEDEWA Inc.**, Hastings, Michigan, in the amount of \$304,639, as the lowest and best bid which meetings all specifications and upon the recommendation of the Utilities Director; Roll Call: All Aye

On motion of Mr. Shoffner and second of Mr. Old, Board adopts resolution authorizing payment for services and supplies provided re: Rebecca Wilson; Roll Call: All Aye (#23-239)

On motion of Mr. Shoffner and second of Mr. Old, Board adopts resolution entering into an agreement with the **Kreimes Co., Inc.**; Roll Call: All Aye (#23-240 - Courtyard Concrete Project at The Meadows at Osborn Park)

On motion of Mr. Old and second of Mr. Shoffner, Board **reconvenes**; Roll Call: All Aye

# CCAO Scholarship Presentation for Erie County Resident Anisha Chopra.

CCAO Service Corporation Manager Steve Caraway and CCAO Communications Coordinator Jessica Newbacher were present. Mr. Caraway stated that each year, CCAO awards five \$2,000 scholarships to students within the districts of Ohio. This year, the Northwest District winner of a \$2,000 scholarship is from Erie County, Ms. Anisha Chopra. Mr. Caraway gave a brief overview of Ms. Chopra's accomplishments including: member of Student Council, participant in Visual and Performing Arts Program, member of United Nations, a volunteer for Board of Developmental Disabilities, Serving Our Senior and Special Olympics. The Commissioners' and Mr. Caraway presented Ms. Chopra with a check for \$2,000.

Ms. Chopra stated she is very grateful for this scholarship and she plans to continue being an active volunteer of the Special Olympics, as she attended the Global Youth Internship Summit and was named the US Youth Embassador for Special Olympics.

# Wheatsborough Solar Project Update.

Union members from Local 129, 688, and 480, President of the Electricians union, and President of Firelands Electric were all present and all gave their support of the PILOT Program for the Wheatsborough project. Each person expressed high interest in keeping the jobs associated with this project local. It was noted, that the construction of a solar panel project in Bowling Green without a PILOT was being constructed and the majority of the license plates at the job site were from out of State.

Mr. Pedder stated the following statistics for the project:

- <u>Civil contractor</u> 25 jobs created starting in August 2023 for 12 months Miller Bros.
- <u>Electrical contractor for high voltage electric</u> 15 jobs created starting October 2023, for 12 months Thompson Electric
- Electrical contractor for medium voltage electric and the solar panels 60-80 jobs created starting November 2023 for 12 months nationwide electric contractor (Conti) will handle this piece of the project, but pulling the majority of the work force out of IBEW Local 129 and potentially a local contractor such as Firelands Electric.
- Racking and Mechanical Engineer 50 jobs created from October 2023 November 2024 National Contractor (Omega Morgan) that will subcontract with local contractors, pulling the majority of the work force out of the local IUOE and Laborers Union halls.

• Fencing and Vegetation - have not been determined yet but will be using local contractors and most likely create over ten jobs.

• During operations, there will be some local and regional O&M staff, as well as, the need for maintenance of vegetation, with the anticipation of creating two jobs.

Mr. Pedder added that at peak construction there will be 200-225 employees on site. DepComm, the head construction company, will have 30 employees as supervisors. Of the remaining 170-200 workers on site, over 100 will be local contractors. The contracts are ready to be signed over the next few weeks. Both Erie County and APEX's attorneys' are working on the Memorandum of Understanding for the PILOT. Nate added that if the PILOT is not approved, there will be changes to the statistics he just noted to make the project more economical for APEX. Nate mentioned the State of Ohio enforces the terms of the PILOT to ensure all terms are being followed. Nate hopes that this will alleviate any apprehension the Commissioners' may have.
