WEDNESDAY, JULY 3, 2024

ALL PRESENT

President Shenigo called the meeting to order at 9:30 a.m. at the Services Center first floor Conference Room 118 and opened with the Pledge of Allegiance.

On motion of Mr. Shoffner and second of Mr. Old, Board **approves the** June 20, 2024 Erie County Commission Meeting Minutes; Roll Call: All Aye

County Administrator Hank Solowiej re Various Issues.

Erie Community Investment Grant Program - County Administrator Hank Solowiej noted that the deadline for the \$500,000 Erie County Community Investment Grant Program has passed. Hank distributed the list of potential projects to the Commissioners. The project requests totaled \$698,000. The committee will be meeting on July 17th to review and score the projects.

Local Preference - Hank mentioned that Assistant Prosecutor Jason Hinners was present to brief the Commissioners regarding the question they had asked about the local preference goal when bidding out projects.

Mr. Hinners stated that, according to the Ohio Revised Code, the Commissioners do not have authority to list in the bid specifications that a contractor is required to employ a certain number of individuals to reside in Erie County, nor can the Commissioners adopt a system of preference for contractors to use county equipment, materials or supplies. Jason noted that the Commissioners' handbook from CCAO also states this information.

Mr. Shenigo asked if it is allowable for the Commissioners to ask the Engineer on how they determined the "lowest and best bid". Mr. Hinners responded, yes, the Engineer makes the recommendation to the Board and ultimately it is up to the Board to decide on the lowest and best bid. Mr. Shenigo stated that the "lowest and best bid" is subjective and there needs to be some justification to support the Engineer's decision and currently that information is not being provided to the Commissioners. Mr. Shoffner agreed and stated that additional information is needed to give explanation as to why a contractor was chosen, other than, they had the lowest bid.

On motion of Mr. Shoffner and second of Mr. Old, Board awards bid re **2024 Resurfacing Program** to **Gerken Paving**, **Inc.**, Napoleon, Ohio, in the amount of \$704,219.75, as the lowest and best bid which meets all specifications and upon the recommendation of the County Engineer; Roll Call: All Aye On motion of Mr. Shoffner and second of Mr. Old, Board adopts resolution **authorizing payment for services and supplies** provided re Hobart Service; Roll Call: All Aye (#24-235)
