Sealed bids will be received by the Erie County Commissioners in Room 327, 2900 Columbus Avenue, Sandusky, Ohio 44870 not later than 9:30 a.m., local time, December 16, 2020, as per O.R.C. 307.86 et seq., and opened immediately thereafter for the furnishing of the necessary materials and construction of the

**MITIWANGA REGIONAL PUMP STATION
CONTRACT A – A STREET AND CRANBERRY CREEK PUMP STATION AND/OR
CONTRACT B – CRANBERRY CREEK FORCE MAIN
ERIE COUNTY, OHIO**

The scope of work consists of two contracts as follows:

Contract A – A Street and Cranberry Creek Pump Station Scope - The scope of this work includes upgrades to the A Street Pump station; including, new pumps, valve chamber, site piping and by-pass pumping, electrical upgrades, building modifications, standby generator, demolition and restoration. In addition, a new submersible, cast in place regional pump station will be constructed at the Mitiwanga WWTP. This work will include a new controls building, wet well, standby generator, demolition, site improvements and restoration.

Contract B – Cranberry Creek Force Main Scope - The scope of this work includes the installation of two 10" diameter force mains, installed in parallel. A total of approximately 41,000 lineal feet of 10" force main will be installed, including plug valves, air release valves and other miscellaneous appurtenances.

The contract documents, including plans and specifications, are on file at the office of the Board of Erie County Commissioners and the Architect/Engineer -- Poggemeyer Design Group, Inc. (PDG). The documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, www.pdgplanroom.com for the cost of printing to be paid to the printing company at the time the documents are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

A pre-bid meeting has been scheduled for Wednesday, December 2, 2020 at 10:00 a.m. at the Huron Basin WWTP, 554 River Road, Huron, Ohio 44839. Bidders are strongly encouraged to attend.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **MITIWANGA REGIONAL PUMP STATION; CONTRACT A – A STREET AND CRANBERRY CREEK**

PUMP STATION AND/OR CONTRACT B – CRANBERRY CREEK FORCE MAIN --- and addressed to the Board of Erie County Commissioners, 2900 Columbus Avenue, Room 327, Sandusky, Ohio 44870.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Erie County Board of Commissioners in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

This procurement is subject to the EPA policy of encouraging the participation of small businesses in rural areas (SBRAs).

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Erie County, Ohio.

The successful bidder will be required to pay not less than the highest applicable minimum wage rates as established by the federal Davis-Bacon Wage Determinations issued by the U.S. Department of Labor.

Erie County, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 90 days after the scheduled closing time for the receipt of bids. The estimated cost of construction is \$1,980,000 for Contract A and \$3,250,000 for Contract B.
