

RULE 4B – SEWER RATES

Section 1. Sewer rates generate revenue to pay for cost of Sandusky and Vermilion to convey and treat a portion of Erie County wastewater, operation and maintenance expenses of the Erie County Wastewater Plants and Sewer Systems, capital improvements, **reducing inflow and infiltration**, equipment purchase, debt service payments, billing and administrative costs, etc.

The charges for sewer are based on customer water consumption. The monthly sewer rates effective with the bills mailed on or about June 17, 2021, and thereafter, shall be:

<u>Metered Water</u>	<u>Charges</u>
US EPA Fee	\$ 2.00 per customer
0 - 2 CCF	\$16.23 (minimum)
3 - 4,066 CCF	\$ 5.96 per CCF
Over 4,066 CCF	\$ 4.78 per CCF

The charges for sewer are based on customer water consumption. The monthly sewer rates effective with the bills mailed on or about June 17, 2022, and thereafter, shall be:

<u>Metered Water</u>	<u>Charges</u>
US EPA Fee	\$ 2.00 per customer
0 - 2 CCF	\$16.23 (minimum)
3 - 4,066 CCF	\$ 6.14 per CCF
Over 4,066 CCF	\$ 4.92 per CCF

The charges for sewer are based on customer water consumption. The monthly sewer rates effective with the bills mailed on or about June 17, 2023, and thereafter, shall be:

<u>Metered Water</u>	<u>Charges</u>
US EPA Fee	\$ 2.00 per customer
0 - 2 CCF	\$16.23 (minimum)
3 - 4,066 CCF	\$ 6.33 per CCF
Over 4,066 CCF	\$ 5.07 per CCF

The charges for sewer are based on customer water consumption. The monthly sewer rates effective with the bills mailed on or about June 17, 2024, and thereafter, shall be:

US EPA Fee	\$ 2.00 per customer
0 - 2 CCF	\$16.23 (minimum)
3 - 4,066 CCF	\$ 6.52 per CCF
Over 4,066 CCF	\$ 5.22 per CCF

RULE 4B – SEWER RATES

Section 1. (Continued)

The charges for sewer are based on customer water consumption. The monthly sewer rates effective with the bills mailed on or about June 17, 2025, and thereafter, shall be:

Metered Water	Charges
US EPA Fee	\$ 2.00 per customer
0 - 2 CCF	\$16.23 (minimum)
3 - 4,066 CCF	\$ 6.71 per CCF
Over 4,066 CCF	\$ 5.38 per CCF

The service area of the Village of Bay View and Bay Bridge Subdivision and all areas served by the Bay View and Bay Bridge Sewer Project shall have the following sewer rates:

Monthly Minimum	\$49.50 per Equivalent Dwelling Unit
Consumption Rate	\$0.66 per CCF

All single-family homes shall be billed for one (1) Equivalent Dwelling Unit per month. For all other customers, an Equivalent Dwelling Unit shall be calculated at the time of connection for each, based on 5 CCF water use per Equivalent Dwelling Unit (rounded down to a whole number) for the Monthly Minimum charge.

Section 2. All sewer bills shall be rendered on a monthly basis and in the full amount due for sanitary sewer used during the billing period.

Section 3. All residential sewer customers who do not have public water and water meter will be charged by Erie County a minimum of 5 CCF/month for sewer usage.
