## **RULE 9A - WATER RATE SCHEDULE**

**Section 1.** The following schedule lists rates which shall be charged for water service.

- A. The monthly water rates effective with the bills due on or about June 17, 2021 and thereafter, shall be:

<b><u>Metered Water</u></b>	<b><u>Charge</u></b>
0 – 2 CCF	Minimum
3 – 4,066 CCF	\$4.55 per CCF
Over 4,066 CCF	\$3.05 per CCF

For the first 0-2 ccf of water used, the minimum charge applies based on customer meter size, as follows:

- E. The monthly water rates effective with the bills due on or about June 17, 2025 and thereafter, shall be:

<b><u>Metered Water</u></b>	<b><u>Charge</u></b>
0 – 2 CCF	Minimum
3 – 4,066 CCF	\$5.12 per CCF
Over 4,066 CCF	\$3.43 per CCF

For the first 0-2 ccf of water used, the minimum charge applies based on customer meter size, as follows:

**Section 2.** The above rates are subject to automatic increases to the per CCF charge as water supply increases are received from the County's water suppliers. These increases shall be in the proportion of the cost of water from particular supplier to the cost from all suppliers.

**Section 3.** All customers' bills shall be rendered on a monthly basis and in the full amount due for water used during the billing period.

**Section 4.** The charge for the bulk sale of water sold to O.R.C. 6117 or O.R.C. 6119 or municipal water districts shall be negotiated as part of a water service agreement with the Erie County Commissioners.

**Section 5.** The charge for bulk sale of water through County-owned coin-operated dispensers (penstocks) shall be at a rate of:

\$0.25 per each 14 gallons dispensed effective June 1, 2021  
\$0.25 per each 13 gallons dispensed effective June 1, 2022  
\$0.25 per each 13 gallons dispensed effective June 1, 2023  
\$0.25 per each 12 gallons dispensed effective June 1, 2024  
\$0.25 per each 12 gallons dispensed effective June 1, 2025
