BAYVIEW SANITARY SEWER PROJECT
(DOOR HANGER)

Dear Resident:

The Board of Erie County Commissioners has awarded the construction contract for this project to Underground Utilities, Inc. of Monroeville, Ohio. The contractor is planning to begin construction in the month of February. The sanitary sewer installation is scheduled for completion by the end of this year. Yard and driveway restoration, and road resurfacing is scheduled for completion by end of May 2017. The contractor will normally work Monday through Thursday, and sometime Fridays during daylight hours. **THIS SCHEDULE IS WEATHER PERMITTING.**

During the construction project there will be mud during rainy days, dust during dry days, as well as road closures, construction noise, etc. There may be days when driveways are blocked due to construction. The contractor will give advance notice when driveways will be blocked for any extended period of time. Please bear with us during these inconveniences. However, if these inconveniences become unbearable please feel free to call either Underground Utilities, Inc. at 419-465-2587 or contact Erie County Department of Environmental Services at (419) 433-7303. We will respond to your concerns as quickly as possible. In case of emergencies the contractor will open the road immediately to allow for emergency vehicles to pass. There will be some tree removal in the public road right of ways for the sewer installation.

A green stake will be placed on your property near the road showing where your sanitary sewer service for your house/business is proposed to be located. Please contact the Contractor at the phone number above if you have any questions concerning the location of the service. The goal is to locate the service close to your septic tank.

When the project is near completion (anticipated Fall 2016), a **Notice to Connect** and a **Sewer Connection Permit Application** will be sent via certified mail to all existing homes and businesses. Do not install the sanitary service lateral to the connection point until you have applied for, paid for (approximately \$230), and received a Sewer Connection Permit from the County. A contractor who is registered with the Department of Environmental Services must install the service lateral. A Registered Contractor List will be provided with the Notice to Connect.

The Erie County Commissioners established tentative Bay View sewer rates under Resolution No. 16-16. The tentative rate is \$49.50 minimum per month plus \$0.66 per hundred cubic feet (CCF) of metered water used. A typical Erie County water and sewer customer uses 5 CCF per month which would be a sewer bill of \$52.80 per month added to your water bill.

Please stay away from construction equipment and open trenches. The construction site is a hard hat area. Excavated trenches are considered unsafe for yourself or your children to go near. Please keep away for your own safety.
